We asked for suggestions and you responded...

During outreaches and presentations, a frequent question is "What is the VA Claim Process?"

Great question! Here are the key parts of the claim process...

Type of Claim is identified (Compensation, Pension, Burial Benefit)

Required documentation is collected by veteran/widow and given to CVSO

Required forms are filled out by CVSO and signed by veteran/widow

Claim is sent to VA for their action.

<u>Compensation Claims</u> - A review of Service Treatment Records and Personnel Records are done. Exams are scheduled (applies to Compensation claims only), after exam results are sent to the VA, the VA Rating Team reviews the forms, medical and personnel records, any private medical records and determines appropriate percentage.

<u>Pension claims and Burial Benefits</u> – all required documents are sent to VA and decision is made on provided documentation for eligibility.

**Turn-around time on decisions vary – please be patient as the VA will be experiencing an increase in claims with the PACT ACT claim processing starting this month.

TRAVEL VOUCHER – VA went to a new paper less procedure for travel vouchers. We can assist you in getting set up with your Travel Pay account. Call the office for more information.

PACT ACT – Claims review and processing was scheduled to take place immediately after January 3, 2022. You can imagine the amount of claims the VA have in the system. PLEASE be patient with the processing, scheduling of exams and decision ratings. We will do our best to keep you advised of the status of your claim. Once it is filed, all we can do is monitor it. We will inquire in the VA system and let you know the most up to date status.

2023 VA Rates - Rates are effective 1 January 2023 for pay purposes. This year's rate increase is one of the biggest ones recently. See below links:
