Wisconsin Veterans Clinic Wisconsin Rapids Sherry Kleinhans

Reported on the several services that they provide. Also talked about other clinics, Green Bay, Madison, Tomah, Milwaukee. Held a question and answer period regarding services. Novemver 5, 2014 is having a stand down for veterans. Wisconsin has a full time approved day care for veterans. Is available for a veteran who need support. Questions about doctors leaving, travel to clinic due to the geographic locations. Veterans can go to any clinic they want. Some clinics have different services to treat veterans. Wisconsin has a facilities to get a hearing aid. test, or be fitted. Requested to have veterans use my health vet system.com. Many of the veteran clinics are overbooked. Hard to get an appointment.

#### **Team River Runner:**

Teaches health & healing through paddlesports. Team River runners is a non profit charity that encourages health & healing for wounded service members, veterans and family members. Veterans are getting medical services, but many many more service members are shwing signs of head trauma, loss of memory, loss of limbs. Even with all the advanced military protective gear they still are injured. Many have a hard time trying to get back in society. Team Rivers runners has experienced personnel on site to assist the veteran. Divers are in the water with each kayak, canoe, inflatable kayak, stand up paddleboards, rafts and more. In the two year of operation They have helped 22 veterans. There is no cost to veterans. ACA insurance. WPS water useage cost. Having a problem finding veterans to come and use the facility.

**Dept Vice Commander: John Thurk** 

Gave a short speech on how he became a Legionaire. He is a Korean War Veteran. Received a card in the mail from headquarters which was in Milwaukee at the time. Stated he needed to be transferred to a local post. He was transferred to post 110 Coon Valley. He stated we need to talk to people and ask them if they are veterans? He stated we need to ask them to join.

Ed Cooper: 10th District

Gave a welcome to 11<sup>th</sup> District. Stated that he is running for Dept Vice Commander. He is currently serving on the Homeland Security Committee because of the veterans who are in dire need of help. Gave a brief report of a veteran who had no food or could not take care of rent. The Veteran was 82 years old. Asked how many are currently serving on committees on post, county, district or national level? Stated every level in the American Legion structure you gain a great deal of knowledge. If you are not on a committee at various levels you should apply.

#### POW/MIA: Sam Solberg

In recognition of POW/MIA recognition day the third Friday in September The American Legion of Wisconsin 1st District has held a silent walk the day for the past 30 years to honor the sacrifices made by American prioioners of war and those still missing. Jim Schmidt reported the following service men and women considered POW/MIA: 58,000 Korean, 78,000 World War II; Vietnam 1461. Wayne Jensen and his post are in the process of writing a resolution to change about 25,000 WWII POW/MIAs to be buried at sea as this is the estimated number killed on or around Navy ships and aircraft. The National Executive committee passed resolution 208. Which states the American Legion petition Congress to authorize a forever POW/MIA stamp to honor the sacrifices Of the brave men and women in the armed forces who are still prisioners, or unaccounted for while Serving in any conflict-past, present, or in the future.

National Security: Jim Young

Reported on Troop and Family support. Initial balance of \$56,276.54, 01/01/14: disbursements Through 10/16/14 (\$11,134.92) donations through 10/16/14 (\$2,956.75) balance 10/16/14 (\$48,098.37). Making sure CSO check to make sure personnel have a DD214. Which is required.

Historian: Don Southworth

There will br a Historians meeting at Mid-Winter Conference. District Historian is recording all important meetingd and District activities in the District History Book. District Historian was recognized for his Post history yearbook at the 2014 State Convention. All posts should have a History yearbook on what they are doing.

Religious Emphasis: Frank Wozniak requested to be notified of any legion members death or a Legion member on sick call. He noticed names on County reports of deaths but was never notified.

The program is for 10<sup>th</sup>, 11<sup>th</sup> 12<sup>th</sup>, graders. After a 175% participation increase last year,we recommended to department DEC to increase nember of scholarships to 55. Not approved. Students are tested on US Government, Wisconsin Government, County Government, Constitution And flag etiquette. Students are required to complete a 300 word essay question to qualify. currently award 45 Scholarships: Participation starts at post level. April 16<sup>th</sup> -22<sup>nd</sup> 2015.

County Youth Government: Arien Herminath

A request from Todd Braun to make sure the County Youth reports are turned in by posts.

Reported to increase number of citizens for 215 to 895. If your post wishes to sponsor more boys send in your sponsorship early. The Department Oratorical chairman had agreed to organize part of the oratorical contest that would allow badger boys to compete at Badger Boys State. There is a plan to attract sponsors, District, County commander to badger boys state. Badger Boys State is working on development of a school of journalism.

The 2014 season for Ameerican Legion baseball has 207 teams registered in Wisconsin. This placed us 4th in the nation in the number of teams at state. The 16 and under tournament was held in Burlington with Janesville winning the championship. The 17 and under was held in Union Grove with Appleton winning the championship. The class A tournament was held in Nekoosa with Waupun winning the title. The AA tournament was in Baraboo with Merrill winning the title. The AAA tournament was held in Plover with Plover winning the State Championship.
