

American Legion Department of Wisconsin 8th District Fall Conference

Fall 2021 Conference Minutes – October 16 2021 Post 263 – New London, WI

1. Commander Zachowitz called the meeting to order at 0900 hours. The colors being in place, all present rendered a hand salute. The Acting Chaplain gave an opening prayer. The POW/MIA flag was placed on the empty chair by the Sergeant at Arms and Resolution 228 was read by Commander Zachowitz. The 1st Vice Commander led the Legionnaires in the recitation of the Pledge of Allegiance. The 3rd Vice Commander then led the attendees in the recitation of the Preamble to the Constitution of the American Legion.

 Commander Zachowitz declared the meeting regularly convened and invited the Waupaca County Commander to the podium to welcome the attendees. The Post 263 Commander and Mayor Mark Herter also welcomed the Legionnaires to New London.
Commander Zachowitz introduced the guests and asked if anyone would like to address the Legionnaires. The SAL Detachment Commander gave a brief overview of Sons activities and encouraged the posts to utilize the SAL to help carry out their programs and activities. The Commander of the First District then spoke about his qualifications for the office of Department Vice Commander. He also spoke about Legion College courses being offered and encouraged all Legionnaires to participate.

4. Commander Zachowitz called Department Commander Greg Eirich to the podium. Commander Eirich said he would like to talk about membership. He said the Department was doing very well last year prior to Covid hitting. Nationally we were pretty much on target, but Covid but the brakes on that. He added that the 8th District was currently meeting the 55% target membership goal and ranked third at 68% among the twelve districts. He said we were going great and should look to assist the posts that are struggling. In cases where the post is not viable, we may have to make the hard decision at the District, County, and Post level to advise a post to turn its charter in. Commander Eirich encouraged the Legionnaires to work closely with their CVSO, get to know him and build a good relationship. He encouraged the Legionnaires to be imaginative and think outside the box to increase membership. We must be positive and think "I can" when it comes to our posts. Changing subjects, Commander Eirich encouraged the Legionnaires to support their 8th District Commander, to include having someone step up and fill the open 8th District Adjutant position. He stressed that the

Commander position is a big job and Commander Zachowitz needs our help to succeed. Finally, he mentioned that they just finished up with the Celebration of Freedom at Portage. He stressed that it was a great event and over 600 students born after 9-11 came in to tour the traveling memorial manned by four fire fighters. Commander Eirich said the Department planned to sponsor a World War II exhibit next year at the county fairgrounds. With only around 200,000 WW II veterans still alive, it should be a great opportunity to recognize the greatest generation. He mentioned the training opportunities that will be available at the Midwinter Conference, including American Legion College, Post Commander, and Adjutant courses. The theme for the conference will be rise and shine, we will be motivated and put a light at the end of the trouble. Commander Eirich challenged Commander Zachowitz to have everyone attend the Midwinter Conference. He then asked for questions. In response to a comment, Commander Eirich encouraged the Legionnaires to get to know the mayor of their community, invite him or her to a meeting and talk about what you are doing. Also, contact the local Chamber of Commerce and get to know your local politicians. In response to a comment, he said that Badger Boys State moved from Ripon to Eau Claire. He expected around 800 boys to attend the next program. We are welcome to attend the veteran's night and be recognized. In response to another comment, he added that the cost of the program may increase due to the move. Commander Eirich said he did not have any solid information on that at this time. The conversation then turned to Wisconsin having another candidate for National Commander. The Commander encouraged all Legionnaires to continue to learn and assume increased roles of responsibility within the American Legion. He particularly stressed the online learning opportunities available on the American Legion website. Finally, he asked Commander Zachowitz for a suitable candidate for his thumbs up award. Past Adjutant Herminath was nominated and accepted the award for his service.

5. Commander Zachowitz spoke about the importance of membership. He reviewed several initiatives taken by his post and encouraged all Legionnaires to redouble their efforts in this area. He also stressed the importance of attendance at legion meeting at post, county, and district functions.

6. The First Vice Commander took a roll call of district and county officers. All officers were either present or excused. He then took a roll call of the posts. A total of 29 Legionnaires from 14 posts and 5 guests were in attendance.

7. Finance Officer Ron Fregien gave a financial report. He also spoke about posts that had not yet paid their district dues for the coming year. Finance Officer Fregien made a motion that the 8th District help pay for a bench at King Veterans Home from the Shell Fund when we have funds available. The motion was seconded and approved. A motion was made and seconded to accept the financial report. The motion was approved. Following the shell being passed, Ron reported that 8th District raised \$132.00 for the fund which now totaled \$687.96.

One speaker, a former part-time employee at King, expressed his concern about the deteriorating safety and security situation at King Veterans Home. He cited staff shortages and a reduction in services as major problems, as well as facility and grounds maintenance shortfalls.
