





## The American Legion, Department of Wisconsin Department Convention, Oshkosh, WI 8<sup>th</sup> District Caucus, July 13, 2018

- 8<sup>th</sup> District Commander Ron Fregien called the meeting to order at 0730. The colors being in place, a hand salute was rendered. The Chaplain gave an opening prayer. The POW/MIA ceremony was performed, followed by the recitation of the Pledge of Allegiance and the Preamble to the American Legion Constitution.
- 2. Commander Fregien declared the Caucus convened and introduced the guests present.
- 3. The Adjutant took the roll and it was determined that a quorum was present.
- 4. Commander Fregien said that he was disappointed with the lack of post representation at the Caucus and would make a concerted effort to improve post participation in 8<sup>th</sup> District meetings during the coming year.
- 5. Various candidates for Department offices visited the Caucus during the meeting and spoke about their qualification for office.
- 6. Old business:
  - a. Commander Fregien reminded all Post and County Commanders to pick up their Department Administrative packets either Friday or Saturday.
  - b. He confirmed that Legionnaires Jean Balz, John Zychowicz, and Jim Jaeger were present to serve as Ballot Clerks on Saturday. He also confirmed that Legionnaire Jim Young was present to serve as Department Assistant Sergeant at Arms.

- c. Finally, he confirmed the names of the Legionnaires who would attend select Department Convention Committee meetings scheduled for Friday afternoon and report on their activities at the Saturday Caucus.
